## Research agenda

My research examines how **development aid** is increasingly aligned with **security and geopolitical objectives** through the **mobilisation of private finance**. I analyse how development banks (multilateral, regional, and national) become key institutional arenas where these logics are negotiated, and how domestic battles over **public banking** architecture shape a country's external aid capacity and geopolitical reach. A comparative thread runs through this work: I study how emerging and middle powers such as South Korea and Morocco navigate the evolving multilateral landscape through multilateral cooperation. Through case studies on institutions including the **UN Green Climate Fund**, the **European Investment Bank**, and the **World Bank**, I show how financialised development – especially within green transition narratives and in the Global South – reproduces logics of extractivism, global competition, and the **coloniality of money**.
